#### **OIML Membership**


- Colombia became Member State in March 2013
- Pleased to welcome Uganda as a Corresponding Member in March 2013
- Unfortunately *Burkina Faso* no longer a Corresponding Member
- Encourage all AFRIMETS members to become at least OIML Corresponding Members
- Important for African countries to be "standards makers" rather than "standards takers"

#### **OIML Membership**

- 58 Member States
- 65 Corresponding Members
- New, slightly reduced fees set by 14th OIML Conference in October 2012 for financial period 2013-2016
  - Member State base contribution: € 14 000
  - Corresponding Member fee: € 1 400
    (= 10 % minimum Member State contribution)
- No entry fee for 2013-2016

## 14th Conference on Legal Metrology

- Held in conjunction with 47th CIML Meeting
- 1-5 October 2012, Bucharest, Romania
- Approved accounts for last four-year period
- Set budget for 2013-2016
- Sanctioned all OIML publications approved by the CIML since the last Conference



- Revision of B 8 Financial regulations
- Revision of B 15 OIML strategy
- Approved clearer policy on arrears and re-admission of Members who have been delisted for non-payment
  - The three years' subscriptions which would have been due before re-admission to be paid
- Interpretation of some terms in the OIML Convention

#### **CIML** Meeting

- Approved revision of B 6 Directives for OIML technical work
- Clarified the issue of the participation of Corresponding Members in OIML technical work

- the OIML will still not provide direct aid to Developing Countries
- the OIML will still not finance technical assistance projects in a particular country


- Significant impact on the development of legal metrology in Bénin

Pause for a moment and think of a typical day, yesterday perhaps. How many times did you do something that required a measurement? You would surely not normally ask yourself that question, but reflect for a moment. Did you look at your watch (you measured time), buy food or produce (you measured mass), fill your car with fuel (you measured volume) or have your blood pressure taken (the pressure was measured)? These along with countless other activities in our daily lives involve some sort of measurement; we are so used to this, that we take many measurements for granted.

There are many aspects to the use of these measurements. We take decisions based on their results, just as simply and automatically as pushing the brake pedal in a car when the speed is over the limit, or cutting down on sweet food if our blood sugar level is too high. The price of much of what we buy is calculated from measurements - electricity, water, food, fuel, to name but a few.
