

Meeting Resolutions

<u>Resolution 1 of 2014</u> – AFRIMETS LMTC Working Group resolved that the deadline for receiving applications from applicants for Legal Metrology School be extend to 4th July 2014. The extension is to allow new applications.

Resolution 2 of 2014 - AFRIMETS LMTC Working Group resolved that the terms of reference for resource persons for the Legal Metrology school should be finalized by 27TH June 2014. The terms of reference to be prepared by an organizing Committee consisting of AFRIMETS and OIML

<u>Resolution 3 of 2014</u> AFRIMETS LMTC Working Group resolved that all Curriculum Vitae's (CV's) of potential resource persons for Legal Metrology School should be finalized by the organizing secretariat by 11th July 2014.

Resolution 4 of 2014 - AFRIMETS LMTC Working Group resolved that TC1B be further split creating two sub-working Group namely the Pre-package Working Group and Regulation Working Group.

Resolution 5 of 2014 - AFRIMETS LMTC Working Group by resolution has requested all Sub-Regional Metrology Organizations (SRMO's) to prepare action plan for consideration and adoption during the 9th AFRIMETS GENERAL ASSEMBLY (GA) taking place in 2015.
