  - Allocating work to Work and Project Groups



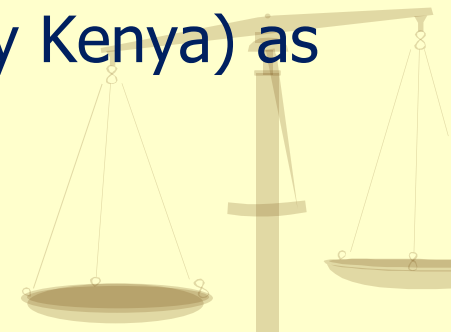

## 6. Resolutions

- **TCL 1 2019** – The TC Legal requests the Secretariat to circulate the minutes of the TC Legal meeting to all meeting attendees in addition to the SRLMO.
- **TCL 2 2019** – Noting the launch of the operational phase of the AfCFTA on 7 July 2019, and recognising the importance of trade in prepackages between AFRIMETS member states, TC Legal requests the AFRIMETS TC Legal Project Group dealing with prepackages, under the Working Group for Harmonisation/ Legislation, to start developing AFRIMETS harmonised requirements for prepackages to ensure their free movement between African countries.
- **TCL 3 2019** – TC Legal appoints EAMET (led by Kenya) as chair of the Working Group on Education.



## 6. Resolutions

- **TCL 4 2019** – TC Legal approved the training plan developed during the TC Legal workshop held in Johannesburg, South Africa and presented to the TC Legal in Cairo, Egypt and further requests the WG on Education to start developing training material for the training program taking into consideration the priorities identified.
- **TCL 5 2019** – TC Legal requests scientific metrology experts to assist TC Legal WG on Education with developing requirements for fundamental education in Pressure, Temperature, Electrical Energy, Gas Chromatography, Dimension, Flow and Time and Frequency
- **TCL 6 2019** – TC Legal requests AFRIMETS to review the AFRIMETS website with the specific view on user interface (ease of use, access to information)
