



- 2020 OIML Award for excellent achievements in legal metrology in developing countries awarded to Indonesia
- Nominations for this year's award open now, deadline for nominations 31 August



- No in-person training courses due to pandemic
- New Task Group on online training
 - Updating existing OIML e-Learning platform
 - New development server, software updates

 - Links to online learning available elsewhere
